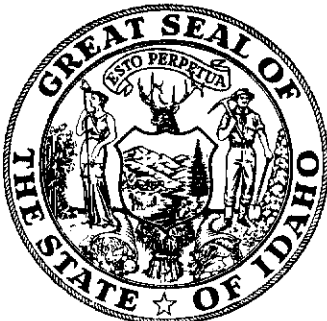

Articles of Amendment to the Articles of Incorporation of Stoel Rives Boley Jones & Grey of Idaho, P.A., a professional service corporation incorporated under the laws of Idaho (the "Corporation"), are herein executed by said corporation, pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, for the purpose of changing the corporate name, as follows:

1. The name of the corporation is Stoel Rives Boley Jones & Grey of Idaho, P.A.

2. Article I of the Articles of Incorporation is amended to read in its entirety as set forth below:

"ARTICLE I

Name

The name of this corporation is Stoel  
Rives Idaho, P.A."

3. The amendment was adopted by the shareholders by unanimous consent as of January 31, 1996.

4. The number of shares of stock outstanding, and the number of shares entitled to vote for the amendment, is 57,908 shares of common stock, \$.01 par value per share, which is the only class of stock of the Corporation.

5. All 57,908 outstanding shares of common stock were voted in favor of the amendment, and no shares were voted against the amendment.

6. No exchange, reclassification or cancellation of issued shares shall be effected by the amendment.

7. The amendment does not effect a change in the amount of stated capital.
