- 7. The limited partners may make such additional contributions to the capital of the partnership as may from time to time be agreed upon by all the partners.
- 8. Upon dissolution and liquidation of the limited partnership, the limited partner's balance in its capital account shall be paid in a lump sum, or if the general partner elects to continue the business, the balance shall be paid in equal monthly installments together with prime rate interest on the unpaid balance over a period not to exceed five years.
- 9. The limited partner shall receive credit to its capital account or distributions of cash as deemed appropriate by the general partner in the amount of fourteen percent (14%) of the profits or losses of the partnership after payment of all business expenses including an agreed salary for the general partner.
- 10. The limited partner has no right to substitute an assignee as limited partner in his place.
- 11. The general partner may admit new limited partners as he deems appropriate except that the terms of admission and the resulting vested rights must be acceptable to all parties. The terms of the agreement admitting the new limited partner shall be deemed an amendment to the limited partnership agreement.
- 12. No limited partner shall have priorities over any other limited partner.
- 13. The death, retirement or insanity of the general partner dissoftves and terminates this limited partnership.

14. The limited partner has no right to demand and receive property other than cash in return for his contribution.
