

ARTICLES OF INCORPORATION
of
THE TETON HUNTING AND FISHING CLUB, OF IDAHO, Limited.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the laws of the State of Idaho, and especially of Title IV, of the Revised Statutes of Idaho. And we hereby certify:

FIRST. That the name of said Corporation is THE TETON HUNTING AND FISHING CLUB, of IDAHO, Limited.

SECOND. That the purposes for which it is formed are to protect fish and game; enforce the laws of the State regarding the same; to acquire land, erect buildings thereon, necessary for such purpose and to maintain a gentlemens sporting and social Club.

THIRD. That the place where its principal business is to be transacted shall be the town of Blackfoot Bingham County Idaho.

FOURTH. That the term for which it is to exist is FIFTY YEARS from and after the date of its incorporation.

FIFTH. That the number of its Directors shall be FIVE, and that the names and residences of those who are appointed for the first year are:

SIXTH. That the amount of the Capital Stock of this Corporation shall be FOUR THOUSAND DOLLARS, divided into FORTY shares of the par value of ONE HUNDRED DOLLARS each.

SEVENTH. That the amount of said Capital Stock which has been actually subscribed is FOUR THOUSAND DOLLARS, and the following are the names of the persons by whom the same has been subscribed, to-wit:
