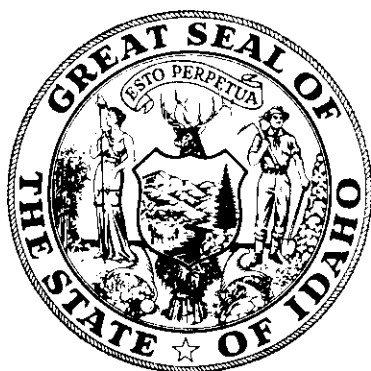

ARTICLES OF INCORPORATION

OF

WILLIAM J. LANGLEY, P. A.

The undersigned, who is a duly licensed attorney at law in the State of Idaho, desires to form a professional corporation pursuant to Chapter 13 of Title 30, Idaho Code for the purpose of practical law and rendering law services in said State, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name. The name of the corporation shall be William J. Langley, P. A.

ARTICLE II

Duration. The duration of the corporation shall be perpetual.

ARTICLE III

Purpose and Power. The purpose for which this corporation is organized is to engage in the practice of law and the providing of legal services and to have and to exercise all powers now or hereafter conferred by law of the State of Idaho upon professional corporations. The corporation shall, in furtherance of its purpose and without

limiting its powers granted by law now existing or hereafter amended, have the power to invest its funds in real property and securities, to acquire, own, and dispose of real and personal property, and to do all other acts to the extent permitted under Chapter 13, Title 30 of the Idaho Code.

#### ARTICLE IV

Capitalization. The aggregate number of shares of stock that the corporation is authorized to issue is Ten (10) shares, which shall be common stock having a par value of zero dollars (\$00,000) per share. Stock shall be issued only to persons who are licensed attorneys in the State of Idaho.

#### ARTICLE V

Initial Office and Registered Agent. The address of the initial office of the corporation and the name of the initial registered agent is as follows:

#### ARTICLE VI

Directors. The corporation shall be governed by a board consisting of no less than one (1) and no more than three (3) directors. Directors shall be stockholders in the corporation and shall be elected by the stockholders.




