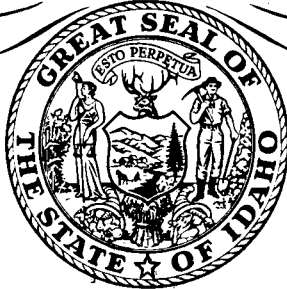

ECOIN-O-MATIC GAS CO., an Idaho corporation, being desirous of changing it's name to WESTERN SUPPLY CO., does hereby make and execute these Articles of Amendment to it's Articles of Incorporation as follows:

I

That the name of this corporation is ECOIN-O-MATIC GAS CO.

II

Article "FIRST" of the original Articles of Incorporation of this corporation shall be and hereby is amended to read as follows:

"FIRST

The name of this corporation is "WESTERN SUPPLY CO."

III

This amendment was adopted by all of the shareholders of the corporation consenting thereto in writing on May 25, 1966 and by a resolution of the Board of Directors authorizing such amendment adopted on May 25, 1966 at a meeting duly and regularly called for that purpose at which all of the directors of the corporation were personally present and voted for such resolution.

IV

This amendment shall not affect the capital stock or state of capital of this corporation and is intended to accomplish only a change of the name of this corporation.
