ARTICLES OF INCORPORATION

OF

SPORTS INCORPORATED OF POCATELLO

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and citizens of the United States of America and of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to Title 30 of the Idaho Code, do hereby certify as follows:

I

The name of the corporation shall be "SPORTS INCORPORATED OF POCATELLO".

II

The purposes for which said corporation is formed are:

- a. To purchase, lease, own, maintain, operate, manage and control diversified sporting activity businesses.
- b. To primarily construct and operate a Go-Cart track to include concession unit rentals and all other allied activities in the performance of such a business.
- c. To establish and operate other businesses normally associated with sporting performances including the purchase and sale of sporting goods.
- d. To buy, sell, hold, acquire, own, mortgage, hypothecate, convey, transfer, lease, exchange, trade and dispose of real and personal property.
- e. To do all other things necessary or convenient which are incidental to or connected with the general business above mentioned, or any part thereof.
- f. To do all things authorized by Title 30, Chapter 1 of the Idaho Code, and particularly, those grants and authorities provided by Section 30-114 of the Idaho Code.

III

The corporation is to have perpetual existence.

IV

The location and postoffice address of the registered office of the corporation is Pocatello, Bannock County, Idaho.

The capital stock of this corporation shall be TEN THOUSAND DOLLARS (\$10,000.00) divided into 1,000 shares of the par value of ten dollars (\$10.00) per share, all shares shall be known as common stock, and shall be non-assessable.


