The Petition of 108 Smelterville residents having been presented to the Board of County Commissioners for the creation of a Village of Smelterville, Idaho, the Board at this time approved the creation of Smelterville Village, and named E. G. James, B. W. Shafer, Floyd Ferguson, Kenneth Grosharth and James S Baker as Trustees to serve until a village council can be elected, and instructed the Clerk to enter the following order of incorporation upon the records of Shoshone County, Idaho:

ORDER OF BOARD OF COUNTY COMMISSIONERS OF SHOSHONE
COUNTY, IDAHO, CREATING THE VILLAGE OF SMELTERVILLE,
IDAHO, DESIGNATING THE METES AND BOUNDS THEREOF AND
APPOINTING FIVE QUALIFIED PERSONS AS TRUSTEES.

A petition having on Sept. 2nd, 1947, been presented to the Board of County Commissioners of Shoshone County, Idaho, for the creation of the Village to be known as Smelterville, Idaho, and defining the metes and bounds thereof, and it appearing from the petition, the records, maps, files and oral evidence presented to the Board of County Commissioners that a majority of the taxable inhabitants of the proposed Village have signed such petition and that inhabitants to the number of 125 or more are actual residents of the territory described in said petition, and it appearing that the petition, records and files are in proper order and that all things required to be done have been done, and the Board being satisfied that a majority of the taxable inhabitants of the proposed Village have signed such petition and that inhabitants to the number of 125 or more are actual residents of the territory described in the petition, NOW, THEREFORE, the Board of County Commissioners does hereby declare that said proposed Village of Smelterville, Idaho, be and the same is hereby incorporated; the Clerk is directed to enter this order of incorporation upon the records of Shoshone County, Idaho; and that the metes and bounds of said Village are hereby designated as follows:

Beginning at the Northeast corner of Lot 1, Block 2, Smelterville, according to the recorded plat thereof on file and of record in the Recorder's Office at Shoshone County, Idaho; thence in a Southerly direction along the East line of said Lot 1 to the Southeast corner thereof; thence at right angles in a Westerly direction along the South line of lots 1 to 7 inclusive of said Block 2; thence continuing across "C" Street and along the South line of Lots 1 to 7 inclusive of Block 3 of said Smelterville to the Southwest corner of Lot 7 of said Block 3; thence in a Northerly direction along the West line of Lot 7, Block 3 a distance of 60 feet more or less to a point on the West line of said Lot 7; thence at right angles in a Westerly direction across "D" Street and continuing along the South line of Lot 10, Block 8, Smelterville and to the Southwest corner of said Lot 10; thence at right angles in a Northerly direction along the West line of said Lot 10, Block 8 and continuing across U.S. Highway No. 10 to the Southwest corner of Lot 2, Block 3, Miller's Amended Addition to Smelterville according to the recorded plat thereof; thence proceeding Northerly along the West line of said Lot 2, Block 3 to a point where the West line of said Lot 2, Block 3, as extended, would intersect with the South boundary of the Washington Water Power right-of-way, as shown by the recorded plat thereof on file in the Recorder's Office of said County; thence in an Easterly direction along the South boundary of said Washington Water Power right-of-way to the Northeast corner of Lot 1, Block 2, Smelterville, being the point of beginning, all situate in Shoshone County, Idaho. Reference is hereby made to the recorded plats on file and of record and herein referred to.

IT IS FURTHER ORDERED by said Board of County Commissioners that the following named persons, having the qualifications provided in Section 49-703, be and they are hereby appointed as trustees of said Village and they shall hold their offices and perform all duties required of them by law until the election and qualification of their successors, as provided by law:

E. G. James, B W Shafer, Floyd Ferguson, Kenneth Grosharth, James S Baker

This order of incorporation is made pursuant to the authority of Section 49-701 I. C. A. as amended.

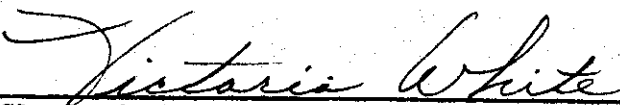
