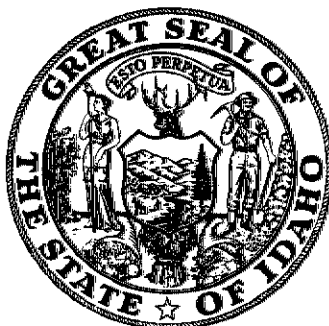

1. Name.




