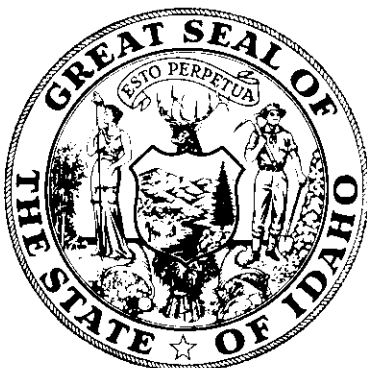

ARTICLES OF INCORPORATION

OF

4C FARM MANAGEMENT, INC.

We, the undersigned, natural persons over the age of twenty-one (21) years, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

CORPORATE NAME

The name of the corporation is 4C FARM MANAGEMENT, INC.

ARTICLE II

DURATION

The duration of the corporation shall be perpetual.

ARTICLE III

GENERAL PURPOSES

This corporation is organized for the purposes of engaging in managing farm properties.

#### ARTICLE IV

##### AUTHORIZED SHARES

The aggregate number of shares the corporation shall have authority to issue is fifty thousand (50,000) shares with a par value of ONE AND NO/100 DOLLARS (\$1.00) per share.

#### ARTICLE V

##### COMMENCEMENT OF BUSINESS

The corporation will not commence business until at least ONE THOUSAND AND NO/100 DOLLARS (\$1,000.00) in cash or property has been received by it as consideration for the issuance of its shares.

#### ARTICLE VI

##### REGISTERED OFFICE AND AGENT

The post office address of the corporation's initial registration office is 496 West 2nd South, Preston, Idaho 83263, and the name of its initial registered agent at such address is CRAIG C. SHAFFER.

## ARTICLE VII

### PRE-EMPTIVE RIGHTS

Each shareholder of this corporation is entitled to full pre-emptive rights, as such rights have been heretofore defined in common law, to purchase and/or subscribe for his proportionate part of any shares which may be issued at any time by this corporation.

## ARTICLE VIII

### DIRECTORS

The number of directors constituting the initial Board of Directors of the corporation is three (3), and the names and addresses of the persons who are to serve as directors until their successors are elected and shall qualify are:

Shares of the corporation shall not be subject to assessment for payment of the debts of the corporation.

ARTICLE XII

CLASSES OF COMMON STOCK

There shall be only one (1) class of common stock.

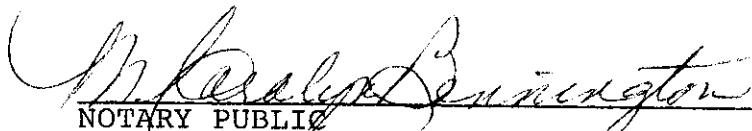
