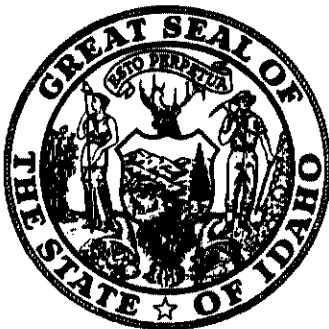
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

SUPER ESTRELLAS PRODUCTIONS, INC.

The undersigned, acting as sole incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME: The name of the corporation is SUPER ESTRELLAS PRODUCTIONS, INC.

ARTICLE II

DURATION: The period of its duration is perpetual.

ARTICLE III

PURPOSES: The purposes for which the corporation is organized are:

1. To conduct, maintain, and operate the business of entertainment, and recreation of the public, including the furnishing of any and all facilities for dancing, music, and exhibitions of every nature, for participation by the public and otherwise; to charge admission fees, rates, rentals, and other forms of payment for so doing; and to do and transact all business properly connected with or incidental to any or all of such objects and purposes.

2. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments thereto.

ARTICLE IV

STOCK: The aggregate number of shares which the corporation shall have authority to issue is 10,000. Said stock shall be of one class designated as common stock with a par value of \$10.00 per share.
