Ι

The name of the corporation shall be TILTH ASSOCIATION.

II

The term of existence shall be perpetual.

III

The purpose of the corporation shall be to establish and maintain an educational and scientific research organization to conduct and promote biologically sound and socially equitable agriculture.

IV

The corporation is organized and operated exclusively for the public good. within the meaning of Section 501 (c) (3) -- Internal Revenue Code of 1954. No part of the net earnings of the corporation shall inure to the benefit of. or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forward in Article III hereof., said purposes being scientific and educational. No substantial part or the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation; and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) and political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles; the corporation shall not carry on any activity not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law), or (b) by a corporation, contributions which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954(or the provision of any future United States Internal Revenue Law).

V

Any person, regardless of age, gender, race, beliefs or national origin, may be a member of the corporation.
