### CERTIFICATE OF INCORPORATION

I, JAS H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**THE UNITED CHURCH OF KELLOGG, IDAHO, INC.**

was filed in the office of the Secretary of State on the **27th** day of **June** A. D. One Thousand Nine Hundred **Fifty-seven** and is duly recorded on Film No. **99** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Kellogg** in the County of **Shoshone** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
OF  
THE UNITED CHURCH OF KELLOGG, IDAHO , INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned being natural persons of legal age and citizens of the United States of America and bona fide residents of the State of Idaho, do hereby associate ourselves together for the purpose of forming a corporation under the provisions of Chapter 11, Title 30 of the Idaho Code, and do hereby adopt the following Articles of Incorporation, to-wit:

Article I

That the name of said corporation shall be THE UNITED CHURCH OF KELLOGG, IDAHO, INC.

Article II

That the term of existence of said corporation shall be perpetual.

Article III

That the location and post office address of its registered office in this state and the principal place of worship shall be Kellogg, Shoshone County, Idaho.

Article IV

The object of this corporation shall be to purchase, lease, receive by gift, legacy, bequest or otherwise, real and personal property wherever situated; and sell, lease, mortgage or otherwise dispose of the same in any manner that shall be useful to and assist in the promotion of the principles and usages of the Christian religion and to build, construct, and to purchase and procure the erection of church edifices for the purpose of administering religious, benevolent, educational and philanthropic work and to do any and all other things necessary, proper and convenient for the carrying out of the object and purposes for which this corporation is formed. This corporation is one which does not contemplate, nor is its object pecuniary gain or profit to the

members thereof.

## Article V

The promotion, operation and maintenance and the government of this corporation shall be under the control of the Board of Directors who shall be eight in number. The names and residences of persons elected to serve as the first Board of Directors of this corporation are as follows:

The number and the above named Board of Directors were decided upon and duly elected at a meeting of the members of the Plymouth Congregational Church of Kellogg, Idaho and the First Methodist Episcopal Church of Kellogg, Idaho, held on the 10th day of June, 1957, at 7:30 p.m. (Mountain Standard Time), at the Federated Church in the City of Kellogg, County of Shoshone, State of Idaho, who met and decided to form this religious corporation; that all of the members of the group present voted in the election and by a majority vote elected the said Board of Directors hereinbefore named; that all directors are of lawful age and residents of Shoshone County, Idaho. The meeting was held after notice of the time and place of holding such election was given by publication in two consecutive weekly publications in Kellogg in the Kellogg-News-Wardner, a newspaper published in Kellogg, Shoshone County, Idaho, which newspaper is located in the City of Kellogg in which said election was held and notice of said election was also given by the posting of a like notice at the door of the said Federated Church at Kellogg, Shoshone County,

Idaho, where the election meeting was held; which notice was posted for a period of two weeks prior to the election date.

That at said meeting Robert W. Cordwell acted as presiding officer thereof and Charlene Whiteley acted as secretary.


