ARTICLES OF INCORPORATION OF D & D LAWN SPRINKLING, INC.

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of full age and citizen of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general corporation laws of the State of Idaho and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

ARTICLE I.

The name of the corporation shall be D & D LAWN SPRINKLING, INC.

ARTICLE II.

The principal place of business shall be D & D LAWN SPRINKLING, INC., c/o W. Gary Davis, 362 Mayfair Court, Boise, Idaho 83706, and the registered post office address of the corporation shall be D & D LAWN SPRINKLING, INC., c/o W. Gary Davis, 362 Mayfair Court, Boise, Idaho 83706.

ARTICLE III.

The objects and purposes for which the corporation is formed as follows:

To conduct sales, installation and service of underground irrigation systems in the State of Idaho. As principal, agent or otherwise to do, in any part, of the State of Idaho, any and every of the things herein set forth to the same extent as natural INAHO SECRETARY OF STATE persons might or could do. - (1) To engage in and to own, operate and run, conduct and manage a business engaged in and to do such other things as are incidental, proper or necessary to the operation of the business or to the carrying out of any or all of the purposes.
- (2) To purchase, lease, acquire, construct and operate buildings and other land improvements, whether or not related, together with all fixtures and appurtenances.
- (3) To engage in every type of lawful business, industry or commercial activity, including, without limitation, the activities set forth in paragraph (1) above.
- (4) To purchase, acquire own, hold, mortgage, pledge, sell, transfer, encumber and in any other manner to dispose of, deal and trade in goods, wares, merchandise and personal property of every class and description, whether at wholesale, retail or otherwise.
- (5) To loan money upon notes, bonds, stocks or any other evidence of indebtedness.

- (6) To establish, form and subsidize or otherwise assist in the establishment organization or formation of other corporations, firms, or companies having for their objects, or some of them, any of the objects mentioned in these Articles, or the development and furtherance of any other undertaking or business enterprise of any description whatsoever, and to purchase, own and hold stock in other corporations and interest in other business enterprises, and to sell the same, and to receive compensation for any services rendered in connection with any of the foregoing matters.
- (7) To borrow money for the business of the corporation and to give security therefor and, in pursuance of the business of the

company, to issue bonds, debentures, promissory notes or other evidences of indebtedness, and to secure the same by mortgage or pledge of all or any of the property of the company, real or personal.

(8) to do generally any and all things which the company may deem necessary, proper and convenient in its said business for the improvement and use of the corporation property and in carrying out and accomplishing the purposes hereinbefore specified, and in addition thereto to have all the general powers granted to corporation by virtue of the laws of the State of Idaho and of any other state in which the corporation may do business.

ARTICLE IV.

The management of the corporation is vested in W. GARY DAVIS, whose address is 362 Mayfair Court, P.O. Box 15245, Boise, Idaho 83715.

ARTICLE V.

The term of existence of the corporation shall be perpetual.

ARTICLE VI.

1:

The total authorized capital stock of the corporation shall be one (1) share of common stock of no par value, with that share being entitled to one vote and not subject to assessment.

ARTICLE VII.

The number of the directors of this corporation at the commencement of business shall be one (1), but the Board of Directors may at any time, by amendment of the By-laws, be increased to any number not exceeding three (3).
