THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

### **FIRST**

The name of the corporation is Northwest Technical Group, Inc.

The period of its duration is perpetual.
