ARTICLES OF INCORPORATION

of

We, the undersigned natural persons, citizens and residents of the State of Idaho, do hereby voluntarily associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt articles of incorporation as follows:

Ι

NAME

The name of this corporation is SUNDOWN RANCH, INC.

ΙI

PURPOSES

To purchase, own, improve, equip, operate, and manage farms and engage in agricultural pursuits, including the raising of all kinds of livestock.

III

DURATION

The duration of this corporation shall be perpetual.

LOCATION

The location of and post office address of the registered office of the corporation is Idaho Falls, Idaho.

AUTHORIZED CAPITAL
