## AMENDED AND RESTATED ARTICLES TO ARTICLES OF INCORPORATED

09 Jan 20 17 10 21

Pursuant to the provisions of 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Idaho Racing, Incorporated.
- 2. The following amendments to the articles of incorporation were adopted by the shareholders of the corporation on May 2, 1986 in a manner prescribed by the Idaho Business Corporation Act:
  - A. The articles of incorporation filed with the Idaho Secretary of State on May 2, 1986, are amended by deleting all of those articles and substituting the following:
    - 1. The name of the corporation is Starting Line Motorsports, Incorporated.
    - 2. The period of its duration is perpetual.
    - 3. Its purpose is to transact the business of purchasing, owning and operating motorized racing vehicles, participating in races and all other businesses not forbidden by law.
    - 4. It shall have authority to issue 10,000 shares, all in one class, no dollar value.
    - 5. The address of its initial registered office is 482 Constitution Way, P.O. Box 1664, Idaho Falls, Idaho 83403. The name of its initial registered agent at such address is Patricia S. Wells.
    - 6. The number of directors constituting its initial board of directs is two, whose names and addresses are:
