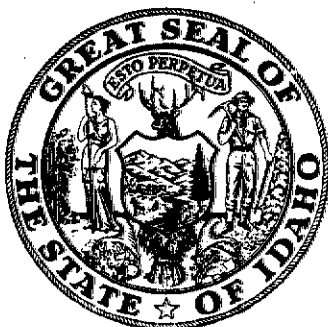

**ARTICLES OF AMENDMENT
to

The following Articles of Amendment to Articles of Incorporation of Ned's Moody Creek Produce, Inc., are hereby adopted pursuant to the Idaho Business Corporation Act (Idaho Code § 30-1-61):

1. Name of Corporation. The present name of the corporation (prior to filing of this amendment) is "Ned's Moody Creek Produce, Inc."

2. Amendment Adopted. The articles are amended to change the name of the corporation from "Ned's Moody Creek Produce, Inc.", to "Moody Creek Produce, Inc.", and accordingly Article 1 of the Articles of Incorporation is hereby amended to read as follows:

1. Name.

The name of the corporation is:

MOODY CREEK PRODUCE, INC.

3. Date of Adoption. The Amendment was adopted by the shareholders at a shareholders meeting held on December 22, 1995.

4. Shares Outstanding. At the shareholders meeting there were 90,000 shares of common capital stock issued and outstanding. All of the outstanding shares were entitled to vote. There is only one class of stock in the corporation.

5. Results of Voting. The vote in favor of adoption of the amendment was unanimous with 90,000 shares voted in favor of the amendment and with no shares voted against the amendment.
