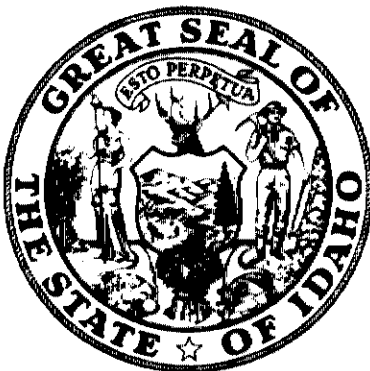

ARTICLES OF INCORPORATION  
OF  
DRUG FREE AMERICA, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a nonprofit corporation for purposes of providing drug education and county services exclusively, pursuant to Title 30, Chapter 11 of the laws of the State of Idaho in such cases made and provided, and hereby agree upon and adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation is:

Drug Free America, Incorporated

ARTICLE II

This corporation is founded for drug education purposes and is constituted to attract substantial support from contributions. This corporation has not been formed for pecuniary profit or financial gain, and no part of the assets, income, or profit of this corporation is distributable to, or inures to the benefit of, its directors or officers. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to

influence legislation, and this corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this certificate, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 as amended (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 as amended (or the corresponding provision of any future United States Internal Revenue law).

### ARTICLE III

1. The purposes of this corporation are:

A. To advance knowledge and information relating to drug abuse and promote public awareness of hallucinatory drugs through educational and scientific means or research for the public good and for all other charitable purposes as the needs of the communities require which are acceptable under the Internal Revenue Code, Section 501(c)(3).

### ARTICLE IV

In order to carry out such purpose, this corporation shall have the following powers:

1. To incur indebtedness and in connection therewith to issue bonds, debentures, notes or other evidences of indebtedness and to secure the same in any manner whatsoever;

2. To exercise any and all powers which exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 of the United States as amended (or corresponding provisions of any future United States Internal Revenue law) and corporations organized under Title 30, Chapter 11, of the laws of Idaho now or hereafter in existence are permitted to exercise;

3. To take and hold, directly or indirectly, by bequest, devise, gift, purchase or lease, either absolutely or in trust for any of its purposes, any real or personal property;

4. To sell, convey or otherwise dispose of any such property and to invest, reinvest, or deal with the principal or the income thereof in such manner as in the judgment of the Directors, will best promote the purposes of this corporation without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of this corporation, or any laws applicable thereto;

5. To do any other act or thing incidental to or connected with the foregoing purpose or in advancement thereof but not for the pecuniary profit or financial gain of its directors or offices.

#### ARTICLE V

This corporation is formed for educational purposes exclusively and, therefore, has no stated capital. No member of this corporation shall be assessed.

#### ARTICLE VI

The property, assets, profits, and net revenue of this corporation are irrevocably dedicated to the purposes for which this corporation is formed, as set forth in Article III above. Upon the dissolution, liquidation or winding up of this corporation, or upon abandonment, the assets of this corporation remaining after payment of or provision for all indebtedness and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 as amended (or corresponding provisions of any future United States Internal Revenue law.)

#### ARTICLE VII

The directors or trustees named in these Articles shall cause to be drawn up By-Laws for this corporation and that said By-Laws shall be accepted by this corporation in the manner provided by law, and said By-Laws may hereafter be amended and repealed in the manner provided therein.

#### ARTICLE VIII

This corporation shall have perpetual existence.

#### ARTICLE IX

#### ARTICLE X

This corporation is expressly authorized to determine by By-Law the number, classes and qualifications for membership, together with the voting rights and other privileges of members, establish dues and assessments and methods of collection thereof, and to increase or decrease the number of the directors from time to time by amendment of By-Laws of this corporation, all in accordance and pursuant to the laws of the State of Idaho.

#### ARTICLE XI

The principal office for the transaction of the business of this corporation shall be in the City of Twin Falls, County of Twin Falls, State of Idaho. The initial registered agent shall be John Wilson, whose address is 1235 Seventh Avenue East, Twin Falls, Idaho 83301.

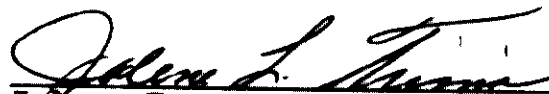

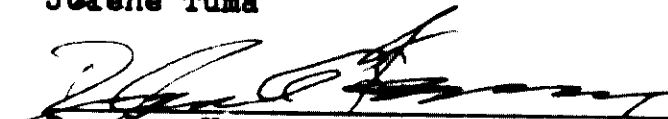
