ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION

of the

NONPAREIL COPPER MINING COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:

That at a meeting of the board of directors of NONPAREIL COPPER MINING COMPANY, LIMITED, held on June 18, 1946, a special meeting of the shareholders of said corporation was called to be convened at the office of the corporation, to-wit: Number 510 Bank Street, Wallace, Idaho, on Tuesday, July 23rd, 1946, at 4 o'clock P.M. for the purpose of considering and acting upon propositions (1) to change the name of said corporation from Nonpareil Copper Mining Company, Limited, to NATIONAL SILVER-LEAD MINING COMPANY; (2) to change the capital and capital stock of said corporation from \$1,500,000. divided into 1,500,000 shares of the par value of \$1.00 each, to \$350,000. divided into 3,500,000 shares of the par value of Ten (10ϕ) Cents each; and (3) to change the term for which this corporation is to exist from fifty (50) years to perpetual; that notice of said special meeting of the shareholders of said corporation was given by said corporation through and by its Secretary by publication of said notice in the Wallace Miner, a weekly newspaper of general circulation published at Wallace Shoshone County, Idaho, the principal office and place of business of said corporation, in the issues of said newspaper of June 20, 27, July 4, 11 and 18, 1946, and by the mailing of a copy of said notice to each and every shareholder of said corporation at his last known post office address as the same appears on the records of said corporation.

That said special meeting of said shareholders of said corporation was held at the time and place named in and desig-

nated by said notice to shareholders, to-wit: on July 23, 1946; that at the date of said special meeting of shareholders the total voting power of all shareholders of said corporation was 1,368,950 shares; that at said meeting there was present in person and represented by proxy a total of 1,035,950 shares of the total voting power of all shareholders of said corporation, being more than two-thirds of the entire voting power of said shareholders of said corporation.

That at said meeting Article One of the Articles of Incorporation of said Nonpareil Copper Mining Company, Limited, was amended by a vote of more than two-thirds of the total voting power of all shareholders of said corporation so as to read as follows:

ARTICLE ONE.

The name of this corporation shall be NATIONAL SILVER-LEAD MINING COMPANY.

That at said meeting Article Four of the Articles of Incorporation of said Nonpareil Copper Mining Company, Limited, was amended by a vote of more than two-thirds of the total voting power of all shareholders of said corporation so as to read as follows:

ARTICLE FOUR.

The term for which this corporation shall exist shall be perpetual from the date of this amendment.

That at said meeting Article Six of the Articles of Incorporation of said Nonpareil Copper Mining Company, Limited, was amended by a vote of more than two-thirds of the total voting power of all shareholders of said corporation so as to read as follows:

ARTICLE SIX.

The amount of capital of said corporation shall be Three Hundred Fifty (\$350,000.) Thousand Dollars, divided into Three Million Five Hundred (3,500,000) Shares of the par value of Ten (10¢) Cents per share.

That said corporation is financially solvent, and that the foregoing amendment of Article Six does not affect the financial condition of said corporation, and that the proposed reduction of the capital stock and the par value thereof will not reduce the fair value of the assets of said corporation to an amount less than the total amount of its debts and liabilities plus the amount of the capital stock as so reduced.
