THESE PRESENTS. that the BY KNOW ALL MEN undersigned, being the President and Secretary of New Horizons bona-fide citizens Opportunities, Inc., and Riding residents of the United States of America, and each being over the age of eighteen (18) years of age, do under, and in pursuance of the general corporate laws of the State of Idaho, hereby submit the Articles Of Amendment, and we do hereby set forth and declare as follows:

I.

The name of the Corporation is New Horizons Riding Opportunities, Inc.

II.

That the Articles of Incorporation are hereby amended to add the following paragraph, which will be designated as Paragraph X, which is set forth as follows:

\*This organization is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activity not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or

corresponding provisions of any future United States Internal Revenue Law) or (b) by a which are contributions to corporation 170(c)(2) of deductible under Section Internal Revenue Code of 1986 (or corresponding provisions of any future United States Internal Revenue Law).

this Upon the dissolution of corporation, assets will be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or corresponding section future of any code), or shall be distributed to the federal government, orto a state government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation then located, exclusively to such organization purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. "

Opportunities, Inc., did meet on the sound day of September, 1989, at which time the Amendment was adopted, and said Amendment received a vote of the majority of the Board of Directors.
