**AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
RENEW, THE CENTER FOR LIVING AND LEARNING, INC.**

The undersigned, consisting of all of the board of directors of Renew, The Center for Living and Learning, Inc. ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following amendment to the Articles of Incorporation of the Corporation ("Amendment").

**ARTICLE I
NAME OF THE CORPORATION**

The name of the Corporation is amended to be Renew Center, Inc.

**ARTICLE II
PURPOSES**

The purposes for which the Corporation is organized and will be operated are amended as follows:

A. To operate the following programs:

1. Person Centered Wellness Program. This program will utilize nutrition consultation and education, Aroma Therapy consultation services, and individual and group growth consultation services to promote wellness in a holistic manner to people in Nampa, Idaho.

2. Community Centered Program. This program will utilize a pro bono case management program to provide efficient needs response to emergent needs in Nampa, Idaho. It will also consult with behavioral health agencies to promote employee resiliency in order to effectively meet the high needs of vulnerable populations in Nampa, Idaho.

3. Education & Research Program. This program will utilize research, community trainings, and an education-based web-site as a medium for provided up-to-date knowledge about the holistic methods of healing and growth.

4. Nature Focused Program. This program will utilize the implicit opportunities in nature including community gardening, outdoor recreation, wilderness activities, and ecological sustainability activities to promote growth on individual and group levels. This will be provided to people living in Nampa, Idaho who demonstrate need.

B. Charitable, religious, educational, or scientific within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt under such Section 501(c)(3).

C. To exercise all powers granted by law necessary and proper to carry out the foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

NON-MEMBER**

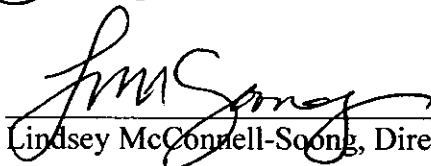
The corporation does not have voting members and shall not be a member organization.
