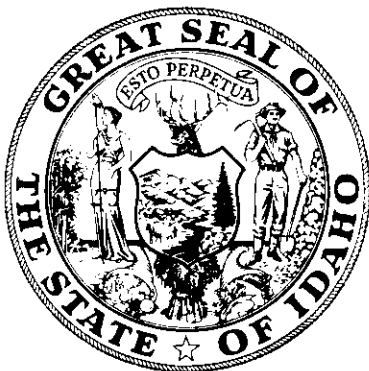

ARTICLE I -- NAME AND PURPOSE

Section A -- Name

The name of this corporation is CHRISTIAN FAITH MINISTRY, Idaho Falls, Bonneville County, Idaho, a religious nonprofit corporation, the duration of which shall be perpetual. It is committed to the historic principles of Christianity and to new and contemporary ways of promoting those principles effectively within a rapidly changing world.

Section B -- Purpose

The purpose of this corporation shall be to proclaim the gospel of Jesus Christ, as set forth in the New Testament, through all areas of its life and work, to win people to faith in Jesus Christ, to commit them actively to the church, and to help them grow in the grace and knowledge of Christ, that increasingly they may know and do his will.

Further, it shall be the purpose of CHRISTIAN FAITH MINISTRY to promote within churches, retreats and to individual inquirers such Christian and religious help or assistance as it may provide within the spirit of this constitution.

The scope of interests to be promoted will include: Bible Study, Prayer, Inner Healing, Pre-marriage Counseling, Gifts of the Spirit at work in the Church, Seed Faith Giving, Discipleship, Dial a Devotion, and such other interests as may be adopted by the Board of Directors.


ARTICLE II -- MEMBERSHIP
