Idaho Falls Congregation of Jehovah's Witnesses, Inc.

We, the undersigned, do hereby certify:

1. That we are the duly appointed president and secretary, respectively of the above named corporation, a religious association incorporated under the laws of the State of Idaho;
2. That on November 8, 1977, a regular meeting of the members of the corporation was duly and properly convened. In addition, pursuant to I.C. 30-1103, notice of said meeting was given by publishing in the Post-Register, a newspaper published in the county wherein such meeting was to be held, public notice of the intention to amend the articles of incorporation and the manner in which it was intended that they be amended. Such notice was published once a week for four (4) consecutive weeks. The first publication having been made on October 13, 1977, and the last publication having been made on November 3, 1977.
3. That of the fifty five (55) members of the corporation, forty three (43) were present at the above mentioned meeting.
4. That the following resolution was put before the members:  
Resolved, That we change our name from IDAHO-FALLS CONGREGATION OF JEHOVAH'S WITNESSES, INC. to IDAHO FALLS WEST CONGREGATION OF JEHOVAH'S WITNESSES, INC.; and,
5. That on motion duly made and carried by the following affirmative vote:

"Be it resolved, that the Articles of Incorporation be, and they hereby are ammended by striking therefrom Article I and

adding thereto the following new Article I, so that the Articles of Incorporation as amended, shall read as follows: The name of the corporation shall be IDAHO FALLS WEST CONGREGATION OF JEHOVAH'S WITNESSES, INC."

"Resolved further that the secretary of the Corporation is hereby authorized and directed to take appropriate action to implement this resolution."
