We, the undersigned incorporators, hereby associate ourselves together to form and establish a corporation NOT FOR PROFIT under the laws of the State of Idaho.

I.

NAME

The name of this corporation is **BUHL WOMEN'S BOWLING ASSOCIATION, INC.**

II.

REGISTERED OFFICE

The location of the registered office is 1020 Main Street, in the City of Buhl, County of Twin Falls, State of Idaho. The registered agent at that address is Michael H. Felton.

III.

PURPOSE

Said corporation is organized exclusively for recreational, charitable and educational purposes that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

PROVIDED HOWEVER, that in all events and under all circumstances, and notwithstanding merger, consolidation, reorganization, termination, dissolution, or winding up of this corporation, voluntary or involuntary, or by operation of law, the following provisions shall apply:

(A) This corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.

(1) Upon dissolution of this corporation, any assets remaining after the payment of debts will be distributed to the Buhl Public School Foundation, Buhl, Idaho, an exempt organization under Section 501(c)(3)

1 of the Internal Revenue Code of 1954 (or the corresponding provision of any
2 future United States law). The recipients may then contribute their interest
3 to such organization or organization organized or operated exclusively for
4 charitable, educational or recreational purposes, as shall at the time qualify
5 as an exempt organization under Section 501(c)(3) of the Internal Revenue
6 Code of 1954 (or the corresponding provision of any future United States
7 law).

9 **CAPITAL STOCK**

10 The corporation shall not have authority to issue capital stock, and the
11 conditions of membership shall be fixed by the bylaws.

12 **V.**

13 **DISSOLUTION**

14 No member of this corporation shall benefit financially from the dissolution
15 thereof. In the event of the dissolution of this corporation, the assets of this corporation
16 shall be distributed as set forth in ARTICLE III hereof.

6 **TERM**


7 The term for which this corporation is to exist is perpetual.


