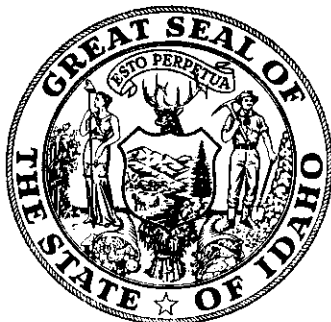
### CERTIFICATE OF AMENDMENT OF

Pursuant to the Idaho Non-Profit Corporation Act, these Articles of Amendment are adopted pursuant to Idaho Code Section 30-327:


1. Name: The name of the corporation is IDAHO ART ASSOCIATION, INC.


2. Amendment: This amendment amends Article I of the Articles of Incorporation to change the name of the corporation from IDAHO ART ASSOCIATION, INC., to IDAHO ART EDUCATION ASSOCIATION, INC. As amended Article I now reads as follows:

The name of the corporation is IDAHO ART EDUCATION ASSOCIATION, INC.

3. Statement of Adoption: The above-stated amendment was adopted on October 2, 1992 at the annual meeting of the members of the corporation at which a quorum of the members were present. Said amendment received a unanimous vote of the members present at such meeting in person and by proxy.
