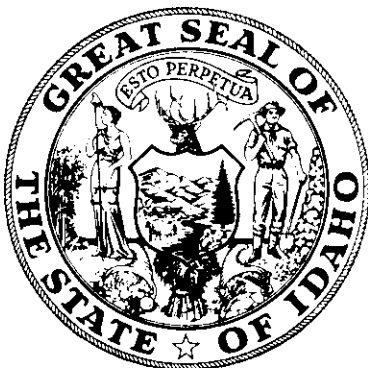

OF

NORTHSIDE REAL ESTATE INVESTMENT, INC.

KNOW ALL MEN BY THESE PRESENT, That we, JACK N. ADAMS and DIANE ADAMS, residents of the State of Idaho and citizens of the United States and natural persons of full age, have this day voluntarily associated ourselves for the purpose of forming a corporation for profit under the laws of the State of Idaho, and we do hereby certify and state:

I.

The name of this corporation is: NORTHSIDE REAL ESTATE INVESTMENT, INC.

II.

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

III.

Said corporation is formed for the following purposes:

A. To carry on and conduct the general business of real estate investment and any other lawful activity authorized by the statutes of the State of Idaho.

B. To lend or advance money or give credit to such person, firms, corporations or associations on such terms as may seem expedient;

or purposes not so declared, and that all other lawful powers not inconsistent herewith are hereby included.

IV.

The location and post office address of the registered office of the corporation shall be 209 S. Lincoln, Jerome, Idaho and the registered agent is JACK N. ADAMS at the same address.

V.

The number of directors of this corporation shall be not less than three directors, except that in cases where all shares of the corporation are owned beneficially and of record by either one or two stockholders, the number of directors may be less than three, but not less than the number of stockholders. There shall be one class of capital stock of the corporation and it shall be known as common stock. The par value of the authorized capital stock shall be the amount of \$5,000.00 divided into 5,000 shares at the par value of \$1.00 per share, all of said stock to be non-assessable.
