ARTICLES OF INCORPORATION OF NEIGHBORHOOD COIN-OP LAUNDRY AND DRY CLEANING ASSOCIATION, INC.

We, the undersigned, Natural persons of the age of twentyone years or more, acting as incorporators of a corporation under
Sections 30-1001 through 30-1005 of the Idaho Code, adopt the following
Articles of Incorporation for such corporation:

The name of the corporation is: NEIGHBORHOOD COIN-OP LAUNDRY AND DRY CLEANING ASSOCIATION, INC.

The period of its duration is perpetual.

Ш

The purposes for which the corporation is organized are:

- (a) The purposes of this Association are to protect the membership from unfair practices from any source, discriminatory legislation and misleading and misrepresentative advertising.
- (b) To exchange views and ideas on operations for the betterment and convenience of the general public.
- (c) To do everything possible to keep the coin laundry and dry cleaning business on a high level of respectability.

IV

The members of the corporation shall be open to any business operating a bona-fide coin operated laundry or coin operated dry cleaners in the State of Idaho as provided for by the laws of the State of Idaho and the By-Laws of this corporation.

The manner in which the directors are to be elected or appointed is by secret ballot at the regular July meeting each year to serve a term of one year except as otherwise provided by these Articles of Incorporation and shall not be eligible for more than two consecutive terms. VI The regular membership shall be open to any business operating bonafide "coin operated laundries" and "coin operated dry cleaners" in the State of Idaho provided they are not manufacturers of laundry or dry cleaning equipment. Regular members shall consist of charter members or members voted upon and accepted by the executive board after the close of the charter. Regular members shall be eligible for full participation, such as voting on motions at regular or special meetings, voting for officers at elections, holding office to which they may be elected, serving on committees and all other business which may come before regular or special meetings of the Association. Any partnership, individual or corporation shall be limited to one regular member and one vote for each coin-op establishment owned by the corporation or partnership. Provisions for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation are to be in accordance with the laws of the State of Idaho dealing with non-profit organizations.
