5 KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, natural
6 persons of full age and citizens of the United States of America, have this day
7 voluntarily associated ourselves together for the purpose of forming a corpora-
8 tion under the laws of the State of Idaho.

9 We do hereby certify --

10 I.

11 That the name of this corporation is and shall be WESTERN LABORATORIES.

12 II.

13 That the duration of this corporation is perpetual;

14 III.

15 That the place of business of this corporation and home office location
16 is 101 Grove Street, Parma, Idaho.

17 IV.

18 That the purposes for which this corporation is formed are, and it
19 shall have the power and authority --

20 a. To buy, sell, lease, mortgage and hypothecate any and all real
21 property, which shall specifically include mineral rights in real property;

22 b. To buy, sell, lease, mortgage and hypothecate any and all personal
23 property;

24 c. To deal in any and all stocks, bonds, notes and any other debentures
25 or evidence of debt;

either within or without the State of Idaho.

e. That the foregoing shall not be a limitation on the powers, authority or purposes of this corporation; that this corporation shall and may engage in any and all types of business regarding real or personal property, shall have the right to issue and hold their own stocks, to buy stocks from other corporations, to issue all types of debentures and to do any and all things within the corporation laws of the State of Idaho;

V.

The total authorized common capital stock of this corporation shall be ONE HUNDRED THOUSAND DOLLARS (\$100,000.00), consisting of ONE THOUSAND (\$1,000.00) shares of ONE HUNDRED DOLLARS (\$100.00) per share common capital stock, which shares shall not be subject to assessment.
