KNOW ALL MEN BY THESE PRESENTS that we, whose names are hereunder subscribed and who are residents of Minidoka County, have voluntarily associated ourselves together for the purpose of forming a religious corporation under the laws of the State of Idaho.

ARTICLE I

NAME AND PURPOSE

- (a) This corporation (congregation) shall be known as the Mini-Cassia Community Christian Church, Inc.
- (b) The purpose for which the corporation is formed is for the teaching and spreading of the Gospel of our Lord Jesus Christ; to provide for the fellowship of the local members of the Body of Christ which is the church of Christ; to acquire, to own, to retain and perpetuate property as may be necessary for the building of the church and for all other religious and charitable purposes properly attributable to a religious organization.
- (c) This corporation is **not** organized for profit.

ARTICLE II

DURATION

The term and existence of this corporation shall be perpetual.

ARTICLE III

REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE IV

GOVERNANCE

This corporation shall remain a free local self-governing organization and shall not be subject to any outside ecclesiastical authority, denomination, or any other governing body or regulating power but will be subject to the Bible as the authoritative rule of faith and action. It shall be free to adopt by-laws pursuant to these Articles for the management of its own affairs.

ARTICLE V

DIRECTORS

- (a) The number of the initial Directors of the corporation shall be three. The initial Directors of the corporation and their addresses are:

- (b) Upon their selection, the Elders of the Mini-Cassia Community Christian Church will be the Directors of the Corporation (congregation).
- (c) The initial Directors will be appointed by a consensus. Subsequent Elder(s) will be elected according to the by-laws of the Mini-Cassia Community Christian Church.

ARTICLE VI

MEMBERSHIP

Membership in this corporation (congregation) shall be established in accordance with the by-laws enacted to govern the affairs of the corporation.

ARTICLE VII

DISSOLUTION

The property, assets and net revenue of this corporation are irrevocably dedicated to the purposes for which this corporation is formed, as set forth in ARTICLES I and IV above. Upon

dissolution, liquidation or abandonment of this corporation, assets of this corporation shall be transferred to such educational, cultural and philanthropic organizations as may be consistent with the purpose of this corporation.

If, at the time of such dissolution as described above, Intermountain Church Planters Association Inc. of Boise, Idaho is in existence, then and in that event, all of the assets will be distributed to the Intermountain Church Planters Association, Inc., Boise, Idaho.
