ARTICLES OF INCORPORATION

OF

MOSCOW TITLE, INC.

I.

We, the undersigned, being three or more natural persons of full age, all of whom are citizens of the United States, or of it's territories or possessions, do hereby voluntarily associate ourselves for the purpose of

IT.

The name of the proposed corporation is MOSCOW TITLE, INC.

forming a private corporation, under the laws of the STATE OF IDAHO.

TTT

The period of it's duration is perpetual.

IV.

The location and post office address of the registered office of this corporation shall be P. O. Box 8489, Moscow, Idaho 83843.

ν.

The registered agent of the corporation shall be Winfred B. Moorer of P. O. Box 8489, Moscow, Idaho 83843.

VI.

The purposes of the corporation are as follows:

- 1. To furnish abstracts of title to real estate; to guarantee the title, and to make insurance of every kind pertaining to or connected with titles to real estate, and to make, execute and perfect such and so many contracts, agreements, policies and other instruments as may be required therefor.
- 2. To act as assignee, receiver, guardian, executor, administrator, and the president or secretary of any such company may take the oath necessary to qualify it to act in such capacity, and such company shall be bound thereby.
- 3. To act as fiscal or transfer agent of any state, municipality, body politic or corporation, and in such capacity to receive and distribute money, transfer, register and countersign certificates of stocks, bonds or other evidence of indebtedness, and to receive and manage any sinking fund thereof on such terms as may be agreed upon.
- 4. To take, receive and hold any and all such pieces of real property as may have been or may hereafter be the subject of any insurance made by such companies under the powers conferred by their charter, and the same to grant, bargain, sell, convey and dispose of in any such manner as they see proper.
- To act as escrow agent and escrow holder and to purchase and sell real estate and take charge of the same.
- 6. To become security for the payment of all damages that may be assessed and directed to be paid for lands taken in the building of any

railway, or for the purposes of any railway, or for the opening of streets or roads or for any purpose whatsoever where land or property is authorized by law to be taken.

- 7. To become security upon any writ of error or appeal, or in any proceeding instituted in any court in this state, in which security may be required.
 - Such other powers as allowed by the laws of the State of Idaho. VTT.

The stock to be issued by this corporation shall be Ten Cents (\$0.10) par value common stock. The total number of shares authorized to be issued shall be 25,000,000 shares of common stock, and the holders and the owners thereof shall have and acquire such voting rights in said corporation as provided by the laws of the State of Idaho. The stock issued by this corporation shall be non-assessable.
