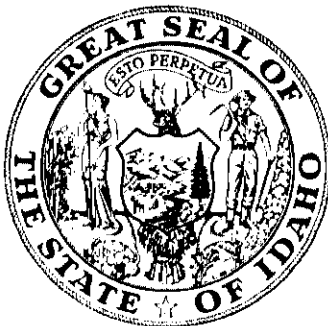
CERTIFICATE OF INCORPORATION OF

The name of the Corporation is JOE INCE TRUCKING,

SECOND. The period of duration is perpetual.

THIRD. Purposes: To engage in inter and intrastate trucking, heavy equipment operation, and equipment repair.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

FOURTH. The Corporation shall have the authority to issue One Thousand (1000) Shares of Common Stock, each share to have No Par Value.
