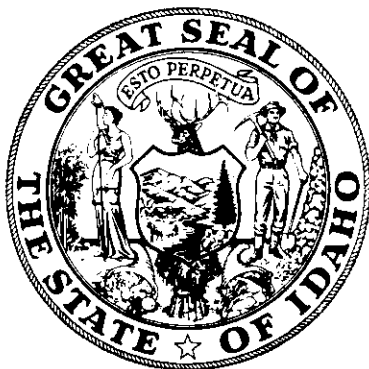

ARTICLES OF INCORPORATION
OF
FAMILY COMMUNICATIONS NETWORK, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being a natural person of legal age and acting as incorporator of a corporation, under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is FAMILY COMMUNICATIONS NETWORK, INC.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are: transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is One Million (1,000,000) with a no par value. There shall be one class of shares, all

of which shall be common shares.

FIFTH:

The address of the initial registered office of the corporation is 1976 Woodruff, Idaho Falls, Idaho 83401, and the name of the initial registered agent at such address is Rick Olsen.

SIXTH:

The number of directors constituting the initial Board of Directors of the corporation is one (1), and the name and address of the person who is to serve as director until the first annual meeting of the shareholders, or until his successor is elected and shall qualify is:


