ARTICLES OF INCORPORATION OF MAX KING FAMILY FARMS, INC.

We, the undersigned, being three natural persons of full age and citizens of the United States, do hereby voluntarily associate ourselves for the purpose of forming a private corporation under the laws of the State of Idaho.

ARTICLE I

The name of the proposed corporation is MAX KING FAMILY FARMS, INC.

ARTICLE II

The purposes of the corporation are as follows:

- (1) To conduct a general farming business.
- (2) To engage in any business whatsoever, either as principal or as agent, or both, which the corporation may determine convenient or proper in furtherance of any of the purposes hereinabove mentioned or otherwise; and to have and acquire all the powers authorized by the laws of the State of Idaho under which the corporation is formed, whether expressly set forth in this article or not, as such laws are now in effect or may at any time hereafter be amended or enacted.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

ARTICLE V
