ARTICLES OF INCORPORATION

OF

ANDREWS TRUCK SERVICE & CLEANING, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, RONALD L. ANDREWS, CAROL R. ANDREWS and HARRY A. ANDREWS, each being a natural person of full age and a citizen and resident of the United States of America, do hereby make and execute the following Articles of Incorporation for the purpose of organizing a business corporation under the laws of the State of Idaho, and we do hereby certify as follows:

FIRST

That the name of this corporation shall be:

ANDREWS TRUCK SERVICE & CLEANING, INC.

SECOND

That the purposes for which this corporation is formed are as follows:

(a) To own or lease and to operate and manage garages, shops and lots for the temporary parking of trucks and motor vehicles; to buy, sell, and deal generally in truck and automotive parts and accessories including petroleum products; to wash, steam clean and wax trucks and motor vehicles; to service and repair trucks and motor vehicles; and to carry on generally such other and incidental business as may be appropriate to the above mentioned activities.

(b) To engage in the business of transportation of all commodities whatsoever as a common and/or contract carrier, both in interstate and intrastate operations.

(c) To own, acquire, hold, lease, sell and dispose of automotive equipment and rolling stock necessary or incidental to the conduct of the activities set forth in subparagraph (b) hereof.

(d) To apply for, own, purchase, lease or otherwise acquire and hold and to sell and otherwise dispose of interstate and intrastate motor vehicle common carrier and/or contract carrier operating rights of all kinds.

(e) To purchase, lease, or otherwise acquire, in whole or in part, the business, assets, good will, rights, franchises, and property of every kind and to take over the whole or any part of such assets and/or liabilities of any firm, person, association or corporation engaged in or having authority to engage in the same general type of business authorized to be conducted by this corporation, or owning property, either real or personal, necessary or suitable for its purposes, and to pay for the same in cash or in the stock and bonds of this corporation, or otherwise; and to hold or in any manner dispose of the whole or any part of the business or property so acquired, and to exercise all powers necessary or incidental to the carrying on of such business.

(f) To acquire, own, use, operate, rent, lease, develop, subdivide, mortgage, convey and otherwise dispose of and in every manner deal with real and/or personal property, or any interest therein.

(g) To purchase or otherwise acquire, hold, sell, exchange, pledge, hypothecate, underwrite, deal in and dispose of stocks, bonds, notes, debentures and other evidences of indebtedness or obligations and securities of any government, state, territory, district, municipality, or other political or governmental division or subdivision, corporation, association, including this corporation.

(h) To borrow or raise money for any purposes of the corporation and to give as security therefor, any mortgage, bond or pledge, conveyance or assignment in trust to the whole or any part of the assets of the corporation and to sell, pledge and otherwise dispose of such securities or other obligations of the corporation, for its corporate purposes.

(i) To enter into and make all necessary contracts for such business with any person, entity, partnership, association, corporation, domestic or foreign, and to perform and carry out, assign, cancel and extend any such contracts.

(j) To enter into any contract, pension plan, cooperative agreement, profit sharing plan, or retirement plan with its officers and/or employees which the corporation may deem advantageous or expedient, or to otherwise compensate such persons for their services as the directors of the corporation may deem fit.

(k) To exercise all or any of its corporate powers and rights in the State of Idaho, or any other State, in which the corporation may qualify to do business.

(l) To carry on any other business, or to do anything in connection with the purposes above mentioned that may be necessary or proper to accomplish successfully or promote the said purposes.

The foregoing clauses, by reason of the specific enumeration of these powers, shall not be held to restrict the power of the corporation to do any of the things within the purview of its general purposes.

THIRD

That this corporation shall have perpetual existence.

FOURTH

That the location and postoffice address of the registered office of this corporation in the State of Idaho and its principal place of business shall be as follows: P.O. Box 142, 227 20th Street North, Lewiston, Idaho, 83501.

FIFTH

That the capital stock of this corporation shall consist of: FIFTY THOUSAND (50,000) SHARES of common stock, having a par value of ONE (\$1.00) DOLLAR per share and an aggregate par value of FIFTY THOUSAND (\$50,000.00) DOLLARS; each of such shares shall be non-assessable when fully paid for.

The capital stock of this corporation shall not be divided into classes, but shall consist of one class only, that being common stock; and each share of stock shall be entitled to one vote in all matters wherein the shareholders of this corporation shall be entitled to vote, and each share shall in all respects be equal to every other share.

The capital stock shall be transferred only in accordance with such rules and regulations as are established by the By-Laws of the corporation, and all restrictions relative to the transfer of such shares of stock of the corporation shall be noted on the stock certificates issued by the corporation.

SIXTH

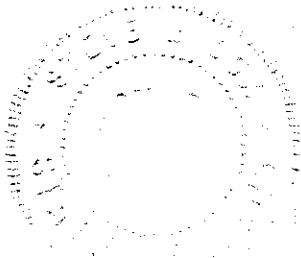

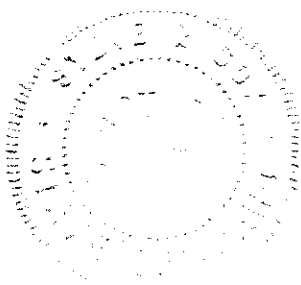

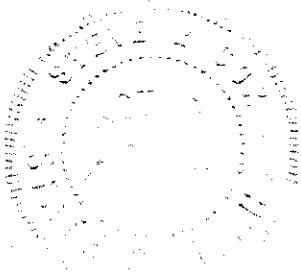
