

ARTICLES OF INCORPORATION

OF

RIVER EXPERIENCES, INC.

I.

The name of the corporation shall be RIVER EXPERIENCES, INC.

II.

The corporation shall exist in perpetuity.

III.

The purpose of the corporation shall be the transaction of any or all lawful business for which corporations may be incorporated under this act, including, without limitation, the conduct of business as an outfitter as defined by the Idaho Outfitters and Guides Act.

IV.

The corporation shall be authorized to issue 10,000 shares of common stock with a par value of #1.

The shareholders shall have all such preemptive rights as permitted under the Idaho Business Corporation Act.
