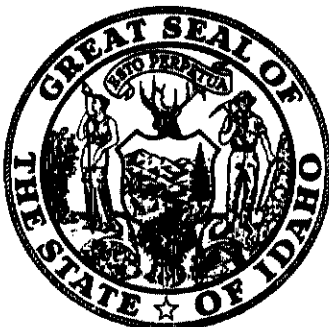
### **CERTIFICATE OF INCORPORATION OF**

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that WE, the undersigned incorporators being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

ARTICLE I.

The name of the corporation is TRI MARKET RADIO BROADCASTERS, INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purposes for which the corporation is organized are as follows:

- (a) To conduct the business of radio broadcasting, both AM and FM modes;
- (b) To do every lawful thing necessary or incidental to the foregoing purpose;
- (c) To transact any and all other lawful business activities of any kind or nature for which corporations may lawfully be empowered under the laws of the State of Idaho.

ARTICLE IV.

The Corporation is authorized to issue one class of shares, in a total amount of 10,000 shares. The stock shall bear no par value. Shares of stock of this Corporation shall

not be transferred or sold until said sale shall be approved by the Board of Directors of this Corporation, in accordance with the duly adopted By-Laws of this Corporation.

The capital stock of this Corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.

#### ARTICLE V.

The address of the initial registered office of the Corporation is 313 7th Ave. East, Jerome, Idaho, 83338.

The name of the initial registered agent at such address is ALLEN D. LEE.

#### ARTICLE VI.

ARTICLE X.

The Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter provided by law, and all rights conferred upon stockholders of this Corporation are granted subject to this reservation.
