# ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that WE, the undersigned incorporators being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of incorporation.

#### ARTICLE 1.

The name of the corporation is TRI MARKET RADIO BROADCASTERS, INC.

#### ARTICLE 11.

The period of its duration is perpetual.

#### ARTICLE III.

The purposes for which the corporation is organized are as follows:

- (a) To conduct the business of radio broadcasting, both AM and FM modes:
- (b) To do every lawful thing necessary or incidental to the foregoing purpose;
- (c) To transact any and all other lawful business activities of any kind or nature for which corporations may lawfully be empowered under the laws of the State of Idaho.
