a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the first day of March, 1955 ,

original articles of amendment, as provided by Section, 30-146, 30-147, 30-151, 30-152 Idaho Code, Agreement of Merger of GUERNSEY DAIRY, INC., into TATE DAIRY, INC.

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. 89 of Record of Domestic Corporations of the State of Idaho,

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

JOINT MERGER AGREEMENT

THIS AGREEMENT, Made and entered into by and between the Guernsey Dairy, Inc., a corporation, and Tate Dairy, Inc., a corporation, executed and signed by each of the directors of the respective corporations, the Guernsey Dairy, Inc., and it's Board of Directors being hereinafter referred to as parties of the first part, and the Tate Dairy, Inc., and it's Board of Directors being hereinafter referred to as second parties, WITNESSETH:

WHEREAS the parties hereto are now, and have been engaged in the business of processing raw milk and other dairy products, and selling said products over retail routes, and

WHEREAS, it is in the best interests of the parties hereto, and all persons interested therein, to merge the Guernsey Dairy, Inc., with the Tate Dairy, Inc., and to carry on and continue the operations of both said corporations in one corporation, and

WHEREAS both of said corporations are domestic corporations, organized and existing under and by virtue of the laws of the State of Idaho, and

WHEREAS it is considered for the best interests of all of said parties that the Guernsey Dairy, Inc. be merged into and become a constituent part of Tate Dairy, Inc., and that said Tate Dairy, Inc. shall survive said merger,

NOW, THEREFORE, in consideration of the mutual covenants it is hereby agreed as follows:

- 1. That the Guernsey Dairy, Inc., now incorporated as a domestic corporation under the laws of the State of Idaho be merged into and become a constituent part of Tate Dairy, Inc., also a domestic corporation, organized and existing under the laws of the State of Idaho.
 - 2. That the said Tate Dairy, Inc. shall be the surviving

corporation into which the said Guernsey Dairy, Inc. is merged by this agreement.

- 3. That the several stockholders of Guernsey Dairy, Inc., shall receive and be issued one share of common stock of the Tate Dairy, Inc., for each and every share of stock of the Guernsey Dairy, Inc., now held by them; that all stock of said Guernsey Dairy, Inc. held by said stockholders shall thereupon be cancelled and retired.
- That all property, real, personal and mixed, of each of the constituent corporations and all debts due on whatever account to any of them, and all choses of action belonging to each of them, shall be taken and deemed to be transferred and invested in Tate Dairy, Inc., the surviving corporation, all as provided by Section 30-155 Idaho Code.
- 5. That the surviving corporation, to wit, Tate Dairy, Inc., shall be responsible for all liabilities and obligations of said Guernsey Dairy, Inc., merged hereunder, in the same manner as if the Tate Dairy, Inc. surviving corporation, had itself incurred such liability or obligations. This agreement is made subject to any and all liabilities of such constituent corporations, or of their shareholders, directors and officers, and the rights of creditors, or of all other persons dealing with such corporations, as provided by Section 30-155 Idaho Code.
- 6. The merger herein provided for shall become effective on ratification and approval by the shareholders of the constituent corporations, as provided by Section 30-152 Idaho Code.
- 7. That on ratification and approval, as aforesaid, the separate existence of the Guernsey Dairy, Inc., shall cease and the Tate Dairy, Inc., shall continue to exist, and is possessed of the rights, privileges and franchises possessed by each of

said constituent corporations, and the Tate Dairy, Inc. shall thereafter possess the right to conduct any and all business theretofore conducted by Guernsey Dairy, Inc., together with right to continue to conduct any and all business theretofore conducted by said Tate Dairy, Inc.

8. That on the ratification of this agreement as provided by law, the Secretary and President of each of said corporations are authorized to certify and sign said agreement and cause the same to be filed and recorded with the Secretary of State of the State of Idaho, and certified copy thereof filed in the office of the County Recorder of Ada County, Idaho, the County and State in which each of said corporations have their offices, as provided by Section 30-152, Idaho Code.

IN WITNESS WHEREOF the directors of each of said constituent corporations have executed and signed this agreement pursuant to a majority vote taken by the Board of Directors of each of said corporations at a meeting of said Board of Directors held on the 15th day of February, 1955, at Boise, Ada County, Idaho.
