

ARTICLES OF INCORPORATION

OF THE CRANE AND GOODE COMPANY. *(limited)*

Know all Men by these presents that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho;

And we hereby certify,

FIRST: That the name of said Corporation is The Crane and Goode Company. *(limited)*

SECOND: That the purposes for which it is formed are to carry on a general merchandise business; to do a general contracting business in lumber, Logs, Telegraph and Electric Poles of all kinds, Cord Wood, Fence Posts, Mining Timbers of all kinds, Railroad Supplies of all kinds; to own or lease and operate Saw Mills; to own or lease and navigate boats and steamboat lines; to build, own and operate Tram roads, pole roads, flumes and ditches, and to buy and sell real estate.

THIRD: That the place where its principal business is to be transacted shall be the town of Coeur d'Alene, County of Kootenai State of Idaho.

FOURTH: That the term for which it is to exist is twenty years.

FIFTH: That the number of its directors shall be five, and that the names and residences of those who are appointed for the first year are:-


