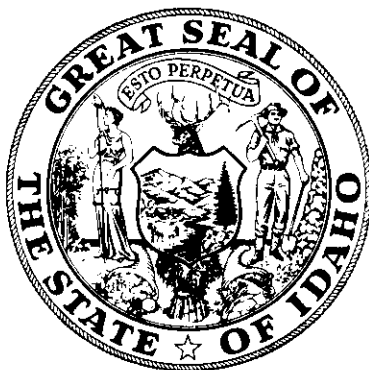

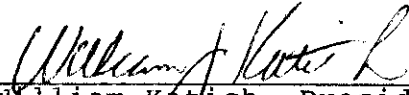
The notice required by §30-1-87 of the Idaho Code to creditors has been complied with. There are no known creditors, nor actual creditors.

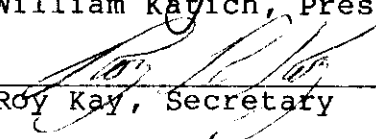
d. All debts, obligations and liabilities of the Corporation have been paid and discharged.
