

# DESIGNATION OF AGENT

And Acceptance of the Provisions of the Constitution  
of the State of Idaho.

Know all Men by these Presents:

That The Union Savings & Investment Co.

any law of the State of Idaho, may be served, as provided by the Constitution and laws  
of said State of Idaho.

State, and to avail itself of the rights, privileges and immunities guaranteed by said  
Constitution and laws, does hereby accept the provisions of the Constitution of the  
State of Idaho for all the intents and purposes contemplated by the provisions thereof,  
relating to such acceptance by other than municipal corporations. (Article XI, Section  
7, Constitution of Idaho).

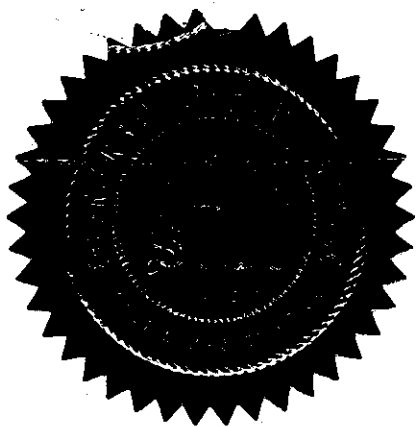
