I. Amend Article V Officers

A. Change Section 2

rege Section 2 Election of Officers

From: The officers shall be elected at the annual meeting for a formion two (2) years or until their respective successors are elected, and shall assume office immediately upon election. No officer shall serve in the same office for more than three (3) consecutive terms.

To: The officers shall be elected at the annual meeting for a term of two (2) years or until their respective successors are elected, and shall assume office immediately upon election. Officer terms shall be staggered. Elections for the president and Secretary shall take place during even numbered years. Elections for Vice President and Treasurer shall take place during odd numbered years. No officer shall serve in the same office for more than three (3) consecutive terms.

## II. Amend Article VIII Board of Directors

A. Change Section 1, subsection b Composition

From: The board of directors shall not be less than nine (9) or more than thirty-two (32).

To: The board of directors shall not be less than seven (7) or more than eleven (11).

B. Change Section 4

From: The quorum for all meetings shall be a majority of the members of the board.

To: The quorum for all meetings shall be at least three (3) voting members of the board.
