



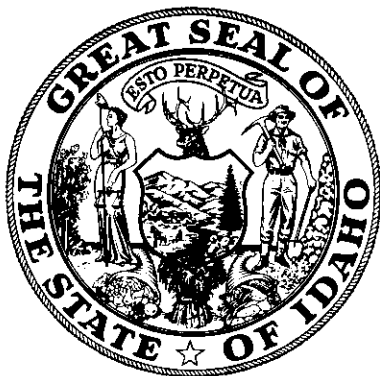
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION OF
VIDEO COMMUNICATIONS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Video Communications, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one hundred shares of one class of common stock. The par value of said stock shall be \$10 per share.

FIFTH: Provisions for the regulation of the internal affairs of the corporation shall be governed by By-Laws adopted by the corporation.

SIXTH: The address of the initial registered office of the corporation is Route 2 Box 103, Grangeville, Idaho 83530 and the name of its initial registered agent at such address is Ralph R. Reynolds.


