ARTICILES OF INCORPORATION

OF THE

CUDDY MOUNTAIN VETERANS OF FOREIGN WARS POST #6232, INC.
KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, members of the Veterans of Foreign Wars, do hereby, in accordance with the rules of such society and under and by virtue of the laws of the State of Idaho, incorporate ourselves and form a Corporation, as follows, to-wit:

First-- That the name of this Corporation is the Juddy Mountain Veterans of Foreign Wars, Post #6232, Inc.

Second -- That this Corporation is formed for patriotic, charitable and benevolent purposes, and especially --

- (a) To promote loyality to the United States of America and its government.
- (b) To accumulate and distribute funds for relief of stricken and destitute veterans of the various military services of the United States and more particularly, for the benefit of the veterans of foreign wars.
- (c) To cultivate social intercourse among its members and assist in improving and ameliorating the moral and social condition of its beneficiaries, and also to promote the general welfare of the Willage of Midvale, Idaho, and surrounding country, and to perform various charitable services for other members of the area.
- (d) To purchase and own such real estate and other property as may be necessary for the purposes of the Corporation.
- (e) For the purposes above specified, to receive donations; to receive, manage, take and hold real and personal property, by gift, grant, devise or bequest, and to raise money by various legal means, all such money to be used for the purpose of this organization.

Pecuniary profit is not the object of this Corporation.

Third-- That the term for which said Corporation shall exist is fifty years.

Fourth -- That the place where its principal place of business shall be transacted shall be in the Village of Midvale, Washington County, State of Idaho.

Fifth-- The number of directors or trustees shall be five (5).
