CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION

Burns International Security Services, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, by the written consent of its sole member, filed with the minutes of the board, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of the Corporation:

RESOLVED, that the Board of Directors of the Corporation hereby proposes and declares it advisable to amend the Certificate of Incorporation of the Corporation by changing the First Article thereof so that, as amended, said Article shall be and read as follows:

"The name of the Corporation shall be Burns International Investigation Services, Inc."

SECOND: That in lieu of a meeting and vote of the sole stockholder of the Corporation, the sole stockholder has given written consent to said amendment in accordance with the applicable provisions of §228 of the General Corporation Law of the State of Delaware.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of §242 and §228 of the General Corporation Law of the State of Delaware on January 26, 1983.
