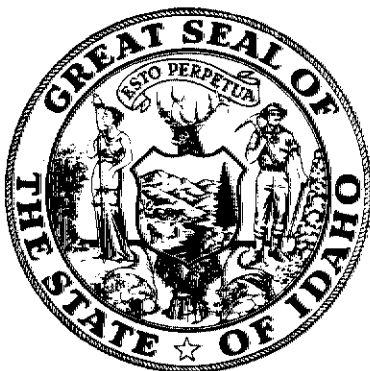

AMENDED ARTICLES OF INCORPORATION
NON-PROFIT

The undersigned natural persons of the age of eighteen years or more, a domestic or foreign corporation, a partnership or an association acting as incorporators under the Idaho Nonprofit Corporation Law, submits the following amended Articles of Incorporation for filing by changing paragraph V to conform to the Internal Revenue requirements.

ARTICLE I. The name of this corporation will be RODEO BIBLE CAMPS OF IDAHO, Inc.;

and its duration shall be perpetual.

ARTICLE II. The purposes for which this corporation is organized are: To introduce teenagers to Jesus Christ, to strengthen the faith of those already born again, to instruct in basic rodeo skills, and give teenagers the opportunity to put their skills into practice by actual rodeo competition. To minister the Gospel of Jesus Christ and share basic rodeo skills, exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. To further the Gospel by instructing teenagers and any lawful purpose in furtherance thereof, none of which is for profit. Our statement of Faith is as follows:

1. We believe the Bible to be the inspired, the only infallible, authoritative Word of God.

2. We believe that there is one God, eternally existent in three persons; Father, Son and the Holy Spirit.

3. We believe in the Deity of our Lord Jesus Christ, in His virgin birth, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and His personal return in power and glory.

4. We believe that the sole condition for receiving eternal salvation from hell is faith in the Lord Jesus Christ, who died a

substitutionary death on the cross for men's sins; recognizing that all men have sinned and have fallen short of the Glory of God.

5. We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a godly life to perform good works.

6. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of damnation.

7. We believe Christ's death was substitutionary penal and vicarious. Although sickness and every other disorder in human life and in the world are the effect of sin, Christ died for sin, not for the effects of sin. Divine healing therefore, which God performs according to his prerogative, is not included in the atonement made by Christ in the same sense that salvation and forgiveness are included in this atonement.

8. We believe in the spiritual unity of believers in our Lord Jesus Christ.

ARTICLE III. The name and phone number of the initial registered agent is LELAND WHITLATCH, 480 Cemetery Road, Cambridge, Idaho 83610; and the address of the initial registered office of the corporation is: Cemetery Road, Cambridge, Idaho 83610.

ARTICLE IV. The names and addresses of the persons constituting the initial board of directors who are to serve until the first annual meeting or until their successors are elected and shall qualify are:

Statement pursuant to Idaho Code 30-314(c):

Management of the affairs of this organization is vested in the Board of Directors.

ARTICLE V. The provision for distribution of assets upon dissolution of this Corporation are: All assets are to be used for the work of the body of Jesus Christ, upon dissolution after paying all just debts and obligations of the Bible Camps the remaining assets will be delivered to Shiloh Bible Conference. However, if the named recipient is not then in existence or no

longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this organization shall be distributed to a Christian fund, foundation or organization and operated exclusively for the purposes specified in section 501 (c)(3) of the Internal Revenue Code.


ARTICLE VI. The directors shall be elected by a majority vote of those members present at the annual meeting.

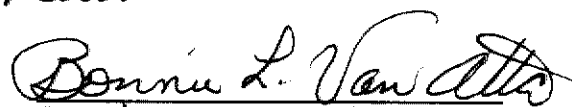
