The undersigned, being the Incorporator of Reclamation Management, Inc., a corporation organized under the Idaho Business Corporation Act (the "Corporation"), hereby adopts the following Articles of Amendment to the Articles of Incorporation for the Corporation, pursuant to Sections 30-1-59 and 30-1-61, Idaho Code.

ARTICLE 1

The Amendment adopted is as follows:
