

ARTICLES OF INCORPORATION

of the

BEFORE ME BY THESE PRESENTS; That we, the undersigned, W.L. McKinney, a resident free holder of the State of Idaho; G.F. McKinney, a resident free holder of the State of Idaho; E.E. Briley, a resident free holder of the State of Idaho; *Lulu Bell* Farnsworth and E.M. Richardt, have this day associated ourselves together for the purpose of forming a private corporation under the laws of the State of Idaho.

And do hereby certify and adopt the following articles of incorporation.

ARTICLE I.

The name of said corporation shall be the "COTTONWOOD HARDWARE & IMPLEMENT COMPANY, LIMITED".

ARTICLE II.

The business which said corporation is formed, is as follows, to-wit:-

to buy and sell and generally deal in all manner and kinds of merchandises, machinery, implements, grain and hay,

and to buy, sell, use and hold all such property, real or personal, as may be necessary or convenient in connection with the said business.

And to carry out or otherwise turn to account contracts of every kind and to maintain offices, warehouses and places of business within the State of Idaho and in general to carry on such operations and enterprises and to do all such things in connection therewith, permitted by the Laws of the State of Idaho, and which shall be necessary or convenient in the conduct of said business and to do any or all things set forth in these articles of incorporation as objects, purposes, powers to the same extent and in the same manner as natural persons might do.

ARTICLE III.

The Capital Stock of this corporation shall be Eight thousand shares of One hundred & no/100 dollars, (\$8400.00), divided into Eighty-four, (84), shares of One hundred & no/100 dollars, (\$100.00), each.

ARTICLE IV.

For which said corporation is formed is a period of Fifty, (50), years and after the date hereof.

ARTICLE V.

The number of directors of this corporation shall be Five, (5), and the qualifications of said directors, who are appointed for the first year, shall be the concerns of this corporation, and until the election of their successors, are as follows; to-wit:-

all of whom are and have been bona fide residents of the State of Idaho, and all of whom are citizens of the State of Idaho.

McKinney Two thousand Dollars, (\$2000), or Twenty, (20), Shares.
Bailey One hundred Dollars, (\$100.00), or One, (1), Share.
Edna Farnsworth One hundred Dollars, (\$100.00), or One, (1), Share.
Ehrhardt, Bailey, (a partnership), One thousand three hundred dollars, (\$1300.00), or Thirteen, (13), Shares.
Adell One thousand seven hundred dollars, (\$1700.00), or Seventeen, (17), Shares.

ARTICLE VII.

The GENERAL PLACE OF BUSINESS of this Corporation shall be the Village of ~~Idaho~~ Idaho County, State of Idaho.
