ARTICLES of INCORPORATION

o f

ALPHA KAPPA LAMBDA FRATERNITY UNIVERSITY OF IDAHO CHAPTER INCORPORATED

KNOW ALL MEN BY THESE PRESENTS, that We, MELVIN J.

ALSAGER; WALTER L. PHELPS; and CHRIS L. SMITH, whose names are hereunto subscribed, desiring to form a Fraternal Corporation under and by virtue of the Laws of the State of Idaho, do hereby associate ourselves together and make and execute in triplicate the following articles of incorporation, to-wit:

ARTICLE I

The Name assumed by this Corporation and by which it shall be known is ALPHA KAPPA LAMBDA FRATERNITY, UNIVERSITY of IDAHO CHAPTER, INCORPORATED, and the duration of the life of this Corporation shall be perpetual.

ARTICLE II

The object, business and pursuit of this Corporation is and shall be:

To build, acquire, own, exchange, operate, lease, rent, or otherwise control, a fraternity house in the vicinity of the University of Idaho, at Moscow, Latah County, Idaho;

To borrow money and issue bonds, notes or certificates of indebtedness therefor;

To rent, lease, hold, exchange, own and acquire such real and personal property as may be necessary or convenient for the use of said Corporation, and to sell, mortgage, pledge, and dispose of the same;

This Corporation assumes it itself and shall possess the rights, powers, priviliges and franchises to do anything necessary, convenient and diesirable in order to accomplish the purposes hereinbefore set forth, and the rights, powers, priviliges, and franchises granted or conferred to like Corporations by the Laws of the State of Idaho.

ARTICLE III

The source of revenue of this Corporation shall be derived from the sale of real property; from assessments on the members of the University of Idaho Chapter of Alpha Kappa Lambda; and from gifts and donations.

ARTICLE IV

The names, titles and respective post office addresses of the incorporators; officers and trustees making these articles of incorporation are:

ARTICLE V

The mode and time of the election of officers and their successors shall be by ballot of the members cast at their regular meeting after the Mid-term examination of the second semester of each school year at the University of Idaho.

ARTICLE VI

The rights and interests of all members shall be equal. Members shall be admitted when initiated into the University of Idaho Chapter of Alpha Kappa Lambda. The Board of Directors shall number no less than three nor more than seven, and shall be elected at the first regular meeting after the mid-term examinations of the second semester of each school year at the University of Idaho.

ARTICLE VII

The location of this Corporation shall be in the City of Moscow, County of Latah, State of Idaho.
