ARTICLES OF INCORPORATION OF YOUNG AND ASSOCIATES, INC.

The undersigned, acting as incorporators under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE NAME

The name of the corporation is YOUNG AND ASSOCIATES, INC.

ARTICLE TWO DURATION

The duration of the corporation shall be perpetual,
